NOMINATION FOR COMMITTEE OF MANAGEMENT FY 17/18

The IWIRC (WA) Committee of Management comprises between 4 and 15 members (being the Executive and the General Committee).

The Executive comprises:

1. a President;
2. a Vice-President;
3. a Secretary; and
4. a Treasurer.

If 4 or less people nominate for positions on the Executive, those people will be duly elected.

If you wish to apply for a position on the Executive, please note that your nomination will need to be seconded by a current IWIRC (WA) committee member at the meeting held for allocation of committee roles.

The General Committee comprises 11 committee members, with various roles allocated as required by the Executive. Some roles will be allocated to committee members by the President, and other roles can be separately nominated for by committee members. This will take place at a meeting once the committee members have been finalised.

If less than 11 people nominate for election to the General Committee, those persons are duly elected.

If more than 11 people are nominated for the General Committee or more than 4 people are nominated for the Executive, an election will be held following the IWIRC (WA) AGM on **Wednesday, 16 August 2017**. Voting procedures will be determined by the Committee.

If you are a current IWIRC (WA) member, you can nominate yourself for a position on the Executive or General Committee. If you are not a current IWIRC (WA) member, a current member will be required to nominate you (and you will need to become a member for FY18).
