

## Financial Report 2018-2019

## **Background**

Restructuring & Insolvency Network WA (RINWA) is a not for profit association that relies on sponsorship and membership funds to deliver high quality professional and educational events. RINWA continuously endeavours to create more value for its members.

RINWA's objective to breakeven to maximise value returned to its members and event attendees.

# **Highlights**

- Membership revenue fell slightly, with a decrease in membership from 61 (FY18) to 56 (FY19).
- Over the year, RINWA collectively had 658 attendees at events.
- Sponsorship funds increased 5% on FY18, with 12 sponsors.
- Event sales increased by 3% on FY18 levels
- Event delivery costs increased by 3% on FY18 levels.
- RINWA generated an immaterial loss of \$937, resulting with a closing net asset balance of \$34,295 for FY19.
