

Financial Report 2019-2020

Background

Restructuring & Insolvency Network WA (RINWA) is a not for profit association that relies on sponsorship and membership funds to deliver high quality professional and educational events. RINWA continuously endeavours to create more value for its members.

RINWA's objective to breakeven to maximise value returned to its members and event attendees.

Highlights

- Membership levels have remained steady at 56 (FY19) and 58 (FY20), however membership revenues have fallen as membership pricing was halved for to \$40 for FY20 from \$80 for FY19.
- Over the year, RINWA collectively had 433 attendees at events (658 in FY19) noting that the coronavirus pandemic cause a halt on hosting physical events since March 2020.
- Sponsorship funds decreased 36% on FY19 levels noting the cessation in events held from March 2020.
- Event sales decreased by 65% on FY19 levels.
- Event delivery costs decreased by 42% on FY19 levels.
- RINWA generated a loss of \$8,251 for FY20, resulting with a closing net asset balance of \$28,044.
- The loss for FY20 is a result of the losses incurred on the following events; FY19 AGM, Sundowner and Christmas Quiz.
